Our ability to provide patients and families with integrated services from inpatient and outpatient addiction services, to primary care and early education, would not be possible without you. City of Boston's COMMUNITY PRESERVATION FUND

The Dimock Center was honored this past year to receive a grant from the City of Boston's Community Preservation Fund to restore more than 100 windows of the historic Dr. Marie Zakrzewska "Z" Building to preserve its founding architecture and character. Funds generated from the Community Preservation Act help communities preserve open space and historic sites, create affordable housing, and develop outdoor recreational facilities.

The City's tremendous generosity provided an opportunity for The Dimock Center to expand our capacity and continue leadership in the provision of healthcare, human services, and education within Roxbury and surrounding neighborhoods. Dimock's commitment to caring for the buildings on an historic campus stems from the deep pride and gratitude to our founding pioneers. This project allowed Dimock to uphold that commitment, while strengthening the integrated continuum of care for members of the community. Upon completion of the Windows Restoration Project and other upgrades to the building, Dimock plans to expand its residential recovery programs to the "Z" Building, providing up to one year of support to people in recovery.

Mayor Walsh visited Dimock's campus in Spring 2019 to celebrate this significant grant, while also marking the one-year anniversary of the Dr. Lucy Sewall Center for Acute Treatment Services, located directly across Dimock Street.

"The renovation of the "Z" Building is a great example of CPA dollars in action: it pays tribute to our City's history and allows Dimock to create a residential recovery program that will serve us into the future," said Mayor Walsh. "Dimock is an asset to our City, and it's an inspiration to me. I thank them for their tireless work in developing affordable treatments, improving access to care, and fighting the stigma around recovery."

In January 2020, we were awarded





The Annual **Road to Wellness 5K Walk/ Run** welcomes more than 1,000 participants, volunteers, and community representatives each year. With the partnership of The Dimock Center, HoodFit, and The Boston Athletic Association, The Road to Wellness continues to expand the number of participants walking and running, and improves the event's accessibility. In 2018, the category for the blind and visually impaired was established, and has since continued to grow. The Tufts Health Plan Health and Fitness Pavilion reached a record number of 42 vendors in 2019 and the Kids' Fun Run hosted by Reimagine Play

had over 40 children running, jumping, and playing.


The Dimock Center's **Steppin' Out** is our largest source of unrestricted dollars. Your generosity and support provides hope for close to 20,000 patients and families annually.





Operating Revenue by Source





PATIENTS BY RACE




PATIENTS BY ETHNICITY



TYPES OF INSURANCE

















CHILDREN AND FAMILIES SERVED BY RACE



The Dimock Difference in Diabetes

In 2019, Dimock piloted a team-based specialty diabetes clinic within primary care. With a team of diabetologist, pharmacist, per diem nutritionist, and connection to social resources, Dimock launched two major components: specialty diabetes services within a community health center, where tertiary specialty diabetes services (with innovative technologies such as continuous glucose monitoring) are more easily accessed by underserved populations; and a series of diabetes self-management classes, where our per diem nutritionist and pharmacist worked with a group of patients with diabetes weekly, focusing on healthy eating, cooking, medication education and physical activity.







Service Days

Service Days at The Dimock Center are one of the most powerful ways that our partners in the Boston community can support our work. The time dedicated by more than **500 volunteers from 15 companies and organizations** made a transformational impact on our campus and programs in the past year. With projects ranging from weekly fitness and financial literacy classes for our residential recovery homes, to creating new and improved green spaces on our campus for patients, families, and students to enjoy, the effort put in by our amazing volunteers has been invaluable.
